Gift Shop Manager Carla Conley

Carla Conley, Gift Shop Manager at Baptist Health Lexington for almost 22 years, has decided to retire at the end of April. As Carla prepares to begin this new chapter of her life by living near her grandchildren and the beaches of South Carolina, we want to recognize the significant contributions Carla made during her tenure as Gift Shop Manager.

When Carla took the baton of leadership for the Gift Shop at Baptist Health, the shop was located on the first floor of the South Tower in a very small space across from Café South. The Gift Shop used an old cash register and the Gift Shop actually had steps that had to be negotiated - which caused more than one person to stumble.

In 1998, Carla led the first of FOUR cash register conversions for the Gift Shop and the Volunteers who staff the Gift Shop. Each change was big and necessary to stay current with technology in retail, but none was bigger than that first step. The latest update took place just last year.

Carla also provided leadership when the Gift Shop moved in 1999 to its current location in the lobby of the 1720 Building. It was anticipated this building would soon become the center of the hospital campus. While it took about seventeen years for this to happen, we are thankful for the visionary planning during the 1990's. With the move, the Gift Shop transformed from being merely a place to pick up essentials, candy, and token gifts to become one of the preferred shopping destinations in Lexington!

The Gift Shop had its first makeover in 2006 when carpet was replaced with durable flooring which totally changed the physical appearance of the shop. Almost 10 years later, another makeover occurred when the countertops were changed and large windows were installed. This coincided with the renovation of the building's lobby.

Another milestone occurred in 2016 when the Gift Shop started taking payroll deduction as payment for items purchased by employees. Carla's desire since starting as manager was to only use payroll deduction in the Gift Shop when technology would allow this to be a completely electronic process. The wait was long, but definitely worth it!

Since the Gift Shop is the fundraising arm of the Auxiliary (of which all Volunteers are members), the primary objective of this position is certainly to make money. Over these 22 years, the total sales in the Gift Shop have been approximately \$9 million, with approximately \$2.5 million in net revenue (net profit). Since 100% of net revenue benefits patients and families of Baptist, this type of financial success has enabled the Auxiliary to help meet many different needs around the hospital over the last two decades.

Thank you, Carla, for providing such capable leadership in the Gift Shop for the last 22 years! Every Volunteer wishes you the very best in retirement!
